AWARE THAT, Article 185 of the Constitution of Kenya, 2010 vests the legislative authority and oversight of the County Governments in the County Assembly;

THAT WHEREAS, under part 2 of the fourth schedule of the Constitution of Kenya, county health services including the human resource for health component is a devolved function;

THAT, the petitioners are nurses who were employed in the year 2005 by the Defunct Nairobi City Council and all with qualification of Certificate in Nursing according to the need of the said employer;

THAT, they were hired on collective Bargain agreement (CBA) term of employment but later promoted to job group 'K' in the year 2020 and in the same year 2020, their term of employment was changed from Collective Bargaining Agreement (CBA) to Salary Renumeration Commission (SRC) term following their request. The reason was to avoid discrimination in regard to salary disparities and always getting a low deal during promotion;

THAT, in the year 2022, the Union of Kenya County Government Workers Union agitated for promotion redesignation, right placement and historical injustice;

THAT, in the year 2023, the Nairobi County Public Service Board released a list of promotion REF: NCPSB/HR/6VOL/11/866 dated 25th May 2023 whereby they only considered 8(eight) Nurses from the forementioned Nurses totalling 79 (seventy-nine) Nurses. All with qualification of Degree (BSN);

THAT, those who were left out paraded in the office of Nairobi County Public Service Board and the office of Chief Officer Medical Service to appeal on their promotion and eventually the promotion following the forementioned appeal was released through letter Refences; HRM/16/VOL.IXL (05) dated 26th September 2023 and surprisingly only 4(four) Nurses from list of 71 (seventy-one) was released;

THAT, the 67(sixty-seven) Nurses who were left out without any written explanation posing unfair administrative action since they were also qualified;

NOTING THAT, the forementioned Nurses met the above injustice due to unprofessional advice from unprofessional human resource personnels;

THAT WHEREAS, petitioners, confirm that efforts have been made to have the matter addressed by the relevant body, it folled to give a satisfactory response;

AND THAT, all the matters in respect of which the petition is raised is not pending before any court of law or constitutional body.

NOW THEREFORE, your humble Petitioners PRAY that the County Assembly of Nairobi County intervenes and ensure that; -

- The Investigation is done and justice be delivered by recommending that the County Public Service Board promotes and back date the aforementioned nurses just like their colleagues';
- 2. The violators are punished to act as deterrence to avoid further violations of the same:
- 3. Audit be done to all human resource officers working in Nairobi city county government, starting with top management and legal action be taken to any human resource officer operating without a practicing license; and
- 4. Make any other order that it may deem fit in the circumstances of this petition


