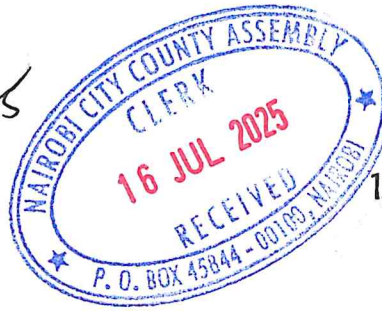

WE THE UNDERSIGNED Citizens of Kenya who are residents of Moi Airbase ward within Nairobi City County.

DRAW the attention of the County Assembly of Nairobi to the following: -

AWARE THAT, Article 185 of the Constitution of Kenya, 2010 vests the legislative authority and oversight of the County Governments in the County Assembly;

THAT WHEREAS, Section 116 of the County Governments Act, 2012 imposes an obligation on the County Government and its agencies to deliver services within its designated area of jurisdiction and Section 117 (1) (a) of the Act provides that the County Government shall give priority to basic needs of the public to ensure that all members of the public have access to basic services;

THAT, the 5th street Eastleigh Squatter village is a public land that squatters were allocated but never given allotment letters since the person who was behind the process retired and later died and those that took over the leadership only took advantage and allocated the land to themselves;

THAT, additionally the Land located in Eastleigh North, Nairobi/Block49/977 Approximate area 0.3302 HA is a public Land that has been invaded by a group of people for their own benefit;

THAT, part of invaded land is inside Maina Wanjigi Secondary School which was previously fenced by the County Government but the invaders demolish it but later the County Government fenced it again;

THAT, the invaded and grabbed public land that was meant for the construction of a Social Hall and ICT Hub would benefit Moi Air Base residents and Nairobians at large to better their lives;

THAT, up to date, the said pieces of land have been invaded and illegally leased to Galole Village Association for a term of 99 years, leaving previously allocated 5th Street Eastleigh squatters without a place to live in;

THAT WHEREAS, petitioners, confirm that efforts have been made to have the matter addressed by the relevant body, it failed to give a satisfactory response;

THAT, all the matters in respect of which the petition is raised is not pending before any court of law or constitutional body.

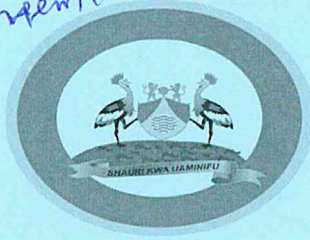
THEREFORE, your humble Petitioners PRAY that the County Assembly of Nairobi County intervenes and ensure that; -

THAT WHEREAS, Section 5(e) of The National Land Commission Act, 2012 requires the Commission to initiate investigations into present or historical land injustices and recommend appropriate redress;

THAT WHEREAS, Section 116 of the County Governments Act, 2012 imposes an obligation on the County Government and its agencies to deliver services within its designated area of jurisdiction and Section 117 (1) (a) of the Act provides that the County

- a) The National Land Commission and all the relevant bodies furnishes the Nairobi City County with the deed plans to facilitate and solve the dispute herein;

- b) The Nairobi City County Government in conjunction with the relevant organs proceed to revoke the lease of the said land;
- c) The said land be surrendered back to the Nairobi City County Government and appropriate deed plans be processed in respect to the public utility land in issue herein; and
- d) The Nairobi City County Government to secure the said Land and hold it in trust on behalf of the Squatters, the Maina Wanjigi School and Nairobians at large.

And your Petitioners will forever pray.
