RE: GAZZETMENT OF MUKURU HEALTH CENTRE

Mukuru Health Centre is a level three health facility in Imara Daima Ward, Embakasi South Constituency. It serves a catchment population of 70,000 Kenyans. Patients seeking services at the facility mainly reside in Mukuru Kwa Njenga Ward, Pipeline ward, Kware and Imara Daima ward. The facility offers a range of primary health care services comprising of maternity services, child welfare services, nutrition services, HIV/TB services, outpatient services, pharmacy, lab and physical rehabilitation services.

Major strides have been realized in service delivery especially the commencement of maternity services in August 2015. To date,

approximately 600 babies have been delivered at the health enter. However, the facility is not gazzeted like other Nairobi City County health facilities which receive funding from HSSF(Health Sector Service Fund) and DANIDA fund. This has led to a variety of challenges in optimizing service delivery at the health centre. The HFMC(Health Facility Management Committee) which is mandated to oversee the management of the health centre is also not gazzeted. This is necessary so that the committee is carries out its mandate legally. Kindly lobby for the resolution of these challenges inorder to guarantee quality care for our patients.


