Hon. Speaker, the said officer having served in the second administration under H.E Mike Mbuvi Sonko, tendered her resignation of the then County Executive Committee Member in charge of Education & Sports with effect from 31" January 2019 to pursue other opportunities. Hon. Speaker, the said public officer was thereafter re-appointed by the then acting Governor Hon. Benson Mutura the same position after the removal of Governor Mike Mbuvi Sonko, in unclear manner that might have contravened the provision of Section 30 (2)(d) of the County Governments Act, 2012, and the Public Appointments (County Assemblies Approval) Act, 2017.

Hon. Speaker, in the statement, the Chairperson should inquire into and report on: -

- Whether the re-appointment of the Ms. Janet Muthoni Ouko complied with the provision of Section 30 (2)(d) of the County Governments Act, 2012 which i. requires the Governor to appoint, with the approval of the county Assembly, the County Executive Committee in accordance with Article 179(2)(b) of the Constitution:
- Whether the re-appointment of the said Public Officer was vetted in line with the requirements of the Public Appointments (County Assemblies Approval) Act, 2017 ii. and Chapter 6 of the Constitution of Kenya, 2010, in particular, where reasons for resignation and/or allegations of abuse of office if any might have been presented;
- The accumulative of all remunerations and allowances paid to the said officer iii. since her re-appointment on 6th January 2021 to the afore-stated position to the date of the appointment of her successor;
- Procedures used by the then Office of the Governor as it were in the reiv. appointment of Ms. Jannet Ouko to the said position; and,
