# 6. <u>MOTION - ESTABLISHMENT OF A COUNTY PUBLIC HEALTH INSURANCE</u> <u>POLICY (Hon. Silas Matara, MCA)</u>

Motion made and Question proposed;

**THAT**, aware that access to quality health care is a Constitutional right, however, millions of Nairobi residents still cannot afford to pay for health services at public or private clinics; **FURTHER AWARE** that even with public health insurance available since 1966, only 20% of Kenyans have access to some sort of medical cover and thus access to basic healthcare in Nairobi County is still a challenge to the majority poor and increasingly, the low income earners who struggle to make ends meet and face the demands of the high cost of living; **OBSERVING** that there are considerable differences in distribution of health outcomes, health determinants and resources across counties in Kenya, Nairobi being one of them, hence innovative ways must be found to fill this gap; **BEARING IN** MIND that Counties such as Makueni County have successfully put in place mechanisms to protect the most vulnerable and provide access to basic healthcare for all; **RECOGNIZING** that healthcare inequalities have significant social and economic costs to the extent that they limit people's ability to realize their full potential in terms of participating effectively in community, social, economic and political life; this **ASSEMBLY URGES** the County Executive to explore mechanisms for the establishment of a County Public Health Insurance Policy targeted at protecting the most vulnerable

and ensuring access to basic healthcare for the County's uninsured low income residents.

Debate ensued; Mover replied; Question put and <u>agreed to;</u>

# 7. MOTION (Hon. Peter Imwatok, MCA)

Motion made and Question proposed;

**THAT**, aware that the issuance of bursaries to the needy students across the County remains one of the most outstanding contribution to the welfare of the needy students; **NOTING** that the timely disbursement of the funds has helped keep such needy students in school and facilitate their smooth learning; **RECOGNIZING** that the Assembly has consistently allocated funds for bursaries each financial year to assist needy students with High School Education; **DEEPLY CONCERNED** that the monies meant for the noble cause have consistently been disbursed late, following outcry and consistent follow up by Members of this August House despite having made such provisions in the budget, including the said monies remaining undisbursed to date, even after commitments were made by the relevant County department; **REGRETING** that this delay has greatly affected the beneficiaries of the said bursaries who had hoped to benefit from the said bursaries who had hoped to benefit from the said monies but remain out of school for lack of fees; this Assembly adjourns pursuant to Standing Order 34 in order to discuss the persistent delays in the disbursement of bursaries despite repeated commitments from the County Executive as a definite repeated commitments from the County Executive as a definite matter of urgent county imoportance.
