3. NOTICE OF MOTION

THAT, aware that Part 2 of the Fourth Schedule to the Constitution of Kenya 2010 provides for the functions of the County Government which include amongst others control of air pollution and implementation of specific National Government policies on Natural Resources and environmental conservation; **further aware** that Section 5 of the Nairobi City County Solid Waste Management Act, 2015 provided that every persons within the County is entitled to a clean and healthy environment and has a duty to safeguard and enhance the quality of the environment; **deeply concerned** that there has been careless disposal of wastes such as medical waste, asbestos and harmful chemicals to the environment and more particularly Nairobi River; **noting** that the asbestos wastes have hazardous material with extremely fine fibers that can remain suspended in air for hours and if handled without caution, it may cause serious chronic health problems such as asbestosis, lung cancer and mesothelioma; **acknowledging** that the County Government in partnership with the National Government through a multiagency taskforce is working towards the restoration and transformation of the County into an environmental friendly area; **further acknowledging** that the National Environmental Management Authority (NEMA) has established guidelines on disposal of asbestos wastes and other waste treatment; this Assembly resolves that the County Executive do the following –

1. Establish a robust policy for effective conservation of the environment from medical and other hazardous waste in the County;
2. Remove all waste discharges in the Nairobi River within a given timeline;
3. Institute the control of all chemicals that goes to sewer treatment sites across the County;
4. Enforce the control of hazardous materials such as asbestos in all buildings accordance with the NEMA directives; and
5. Ensure the control disposal of medical waste from both public private hospitals and clinics which do not have incinerators.
