**4. NOTICES OF MOTION:**

- a. **THAT**, this Assembly approves the **Report of The Select Committee on Appointments on the Vetting of Nominees for Members of the County Executive Committee Responsible for Various Sectors**, laid on the Table of the Assembly, today, Tuesday, 19th March, 2019.

- b. **THAT**, aware that Section 10 of the Nairobi City County Inspectorate service Act, 2017 provides for establishment and maintenance of an inspector training institution for purposes of training and re-training City Inspectorate Officers in accordance to a training curriculum; **further** aware that Section 10 Sub-section 4 of the same Act mandates the Nairobi City County Public Service Board to develop guidelines on curriculum, examination and certification of inspectorate trainees; **acknowledging** that the Nairobi City County's inspectorate department has over four hundred county enforcement officers whose primary duty is enforcement of County laws and regulations, which the department undertakes in key areas such as markets, licensing among others; **further acknowledging** that law enforcement is crucial to harmonious living and the orderly conduct of business in the City; **concerned** that the current inspectorate training college in Dagoretti has no modern training facilities with clear administration organogram, updated curriculum to embrace devolution which may impede the enforcement of County Laws and Regulations; **noting** that with a well-structured institution, the County could increase its revenue, the Assembly urges the County Executive to develop a policy that will institutionalize the Nairobi City County Inspectorate Training College with its organization structure, curriculum that will provide for paralegal training, anti-terrorism, disarmament, compliance and enforcement; and provide modern facilities to be used in training of both inspectorate officers and other forms of training to enhance county public service delivery.

- c. **THAT**, aware that Article 43 Sub-Article (1) (a) and (2) of the Constitution of Kenya 2010 provides that every person has the right, to the highest attainable standard of health, which includes the right to health care services and that a person shall not be denied emergency medical treatment; **further aware** that Health Services including County Health facilities, promotion of primary health care and ambulance services have been devolved to the County Governments pursuant to paragraph 2 of Part Two of the Fourth Schedule to the Constitution; **concerned** that emergency care still remains underdeveloped and underequipped both in public and private health facilities where victims and survivors of road accidents, terrorism, poisoning, fires, collapsed buildings, disease or epidemics are exposed to avoidable death; **acknowledging** that Ambulance services are the primary providers of a 24/7 response to medical and trauma related emergencies; **noting** that lack of proper emergency services in Nairobi County contributes significantly as the cause of thousands of deaths every year, this Assembly urges the County Executive to provide at least one fully equipped ambulance with well-trained emergency medical care personnel in every Ward and establish medical emergency policy and charter in the County.

- d. **THAT**, aware that Article 186 (1) of the Constitution of Kenya 2010, and paragraph 5 of the Fourth Schedule to the Constitution provide for the functions and powers of County Government on County transport including county roads, street lighting, public road transport traffic and parking; **further aware** that the City has designated preferential parking zones and bus termini throughout the City with parking restrictions for each zone; noting that recent years have witnessed a marked increase in the number of vehicles in the County; **concerned** that there are limited number of parking slots across the County making it difficult for motorists to get a slot especially during working hours; **further concerned** that some of the available parking slots are in a dilapidated state giving motorists option of using private parking services thus denying the County revenue; **acknowledging** that a good percentage of County revenue is from parking services, this Assembly urges the County Executive to establish more car parks in off-street parking areas outside the Central Business District, build multi-storey car parks in available County land and upgrade the existing ones to ease the pressure on the available spaces, provide efficient parking services to motorists and boost revenue collection for the County.
