**“Honourable Members,**

You may recall that yesterday, Tuesday, 29<sup>th</sup> October 2019 I issued a Communication in the Assembly indicating the intention of the newly established Nairobi City County Assembly Service Board, which is to co-opt and create ADHOC Committees that will examine and evaluate the **Administrative aspects, the Financial aspects** and the **Technical aspect** of the Assembly with a view of improving efficiency for its posterity.

Hon. Members, you may equally recall that I committed to share with you any of such development.

The County Assembly Service Board is established pursuant to Section 12(1) of County Government Act and Section 8 of the County Assembly Services Act, 2017 with its functions stipulated in Section 11 of the same, one being to; Determine and review the terms and conditions of service of persons holding or acting in the offices of the Service and to Initiate, co-ordinate and harmonize policies and strategies relating to the development of the Service.

In that spirit Hon. Members, the County Assembly Service Board at its meeting held on 27<sup>th</sup> October 2019 deliberated on the formation of

ADHOC Committees enable the Board to come up with a report that will show the status of the issues under the review and advice on the way forward based on its finding.

Honorable Members, flowing from the foregoing, I therefore wish to convey to you the following resolutions by the County Assembly Service Board, THAT; -

The following key areas shall be considered by the ADHOC committees are with great need for evaluation.

- a) Members and Staff Wellness;
- b) Finance and Accounts;
- c) Administration; and
- d) Management of Manpower and Labour Force.

As the Chairperson of the Board, we will be deliberating on the Membership of the said Committees and give a communication on the same”
