**THE BUILDING BRIDGES INITIATIVE (CONSTITUTIONAL AMENDMENT)
BILL, 2020**

“Hon. Members, without appearing to pre-empt the debate on the business of today’s sitting, I wish to take this opportunity to inform you that in today’s sitting we are set to respond to the highest call of our duty by exercising a constitutional mandate. Hon. Members, you will recall that on Tuesday, 9 February 2021 and pursuant to Article 257 of the Constitution of Kenya, the Building Bridges Initiative (Constitutional Amendment) Bill, 2020 was introduced in the County Assembly and committed to the Sectoral Committee on Justice and Legal Affairs for consideration and reporting. The Committee has since considered the Bill and sought the views of the public in accordance with Article 196 of the Constitution. Accordingly, the Committee shall be tabling its report in a short while. Hon. Members, the report is only meant to help you make an informed decision and I will request the Clerk to circulate to all Members immediately it is tabled. However, at the end Hon.
