THAT, aware that Part Two of the Fourth Schedule to the Constitution of Kenya 2010, the functions and powers of the County Governments, among others, covers public health; further aware that Section 118(b) of the Public Health Act, Cap 242 identifies as nuisance, any dwelling or premises or part of a construction in such a state as dirty to be dangerous to health; **NOTING THAT** that Nairobi County is the entry point into the country by international guests; **FURTHER NOTING THAT** the aesthetic characteristics of the city gives the first impression about its general organization and national character; **COGNIZANT THAT** the County Government and the Nairobi Metropolitan Services (NMS) have separately issued public notices to owners of buildings to repaint in line with their Nairobi City beautification initiative; **CONCERNED THAT** to a large extent, property owners have ignored to comply with the said notices; **REALIZING THAT** the County has the responsibility to make laws and policies in peoples' interest which they hold in trust; this Assembly resolves the County Executive and the Nairobi Metropolitan Services(NMS) moves with speed to enforce the aforementioned notices on repainting of building's in the City County.
