- **1.** The Assembly assembled at thirty minutes past Two O'clock.
- **2.** The Proceedings were opened with Prayer.

QUORUM OF THE ASSEMBLY

The Hon. Speaker having confirmed that there was Quorum called the Assembly to order.

5. NOTICE OF MOTION - HON. BENSON MWANGI, MCA

Subject: Establishment of a Street to School program for the street children.

AWARE that Article 21 (3) of the Constitution of Kenya 2010 provides that all State organs and all public officers have the duty to address the needs of vulnerable groups within society, including women, older members of society, persons with disabilities, **children**, youth, members of minority or marginalized communities, and members of particular ethnic, religious or cultural communities" **FURTHER AWARE**

that Article 53 (1) of the same constitution dictates that every child has a right inter-alias;- (b) to free and compulsory basic education; (c) to basic nutrition, shelter and health care; (d) to be protected from abuse, neglect, harmful cultural practices, all forms of violence, inhuman treatment and punishment, and hazardous or exploitative labour; CONCERNED that according to the 2019 Kenya Population and Housing Census Report for the exercise conducted from 1st to 10th April, 2018 indicated that Kenya had a total of 46,639 street persons, out of whom the majority of the street persons being 21,550 were age 10 to 34 years, and below 19 years being 15,752, **FURTHER CONCERNED** that the highest concentration of street persons according to the said report was found in Nairobi (15,337 persons), Mombasa (7,529), Kisumu (2,746), Uasin Gishu (2,147) and Nakuru (2,005). **DISTURBED** that street children population in Nairobi County has increased over the years which has seen them thrust into a bleak, harsh and depraved environment often fraught with constant and sustained danger in various forms such as; Harassment, Violence, Drug abuse and trafficking, Sexual exploitation, Loneliness and fear, Physical and emotional abuse and neglect, Starvation, Exposure to the elements, Early pregnancy and Poor hygienic and sanitation conditions; **FURTHER DISTURBED** that most of the street children lack basic needs including education despite the Government intervention towards free Education system; this Assembly therefore resolves that the County Executive undertake the following measures;-

- i. Initiate a **"Street to School"** campaign programs towards eliminating children from the streets to school with a proper guideline for the same;
- ii. The County Executive to establish a street-children rescue center for learning through a Public Private Partnership with non-state agencies and equip it with personnel;
- iii. A one-month Public Notice be issued to the General Public on removal of all homeless children from the street and enroll them on the Street to School Program forthwith; and,
- iv. Homeless children that shall upon the expiry of the removal notice be promptly nabbed and directed to Ruai Rehabilitation Center for rehabilitation and subsequently enrolled in the "Street To School" program.

6. NOTICE OF MOTION - HON. MARK MUGAMBI, MCA

Subject: Establishment of County Rehabilitation Centres

THAT, aware that Article 55 of the Constitution provides for the State to take measures, including affirmative action programmes to ensure that the youth have opportunities to associate, be represented and participate in political, social, economic and other spheres of life, access employment and are protected from harmful cultural practices and exploitation; **further** aware that Part Two of the Fourth Schedule to the

Constitution provides for the functions of the County Government which include ensuring and coordinating the participation of communities and locations in governance at the local level and assisting communities and locations to develop the administrative capacity for the effective exercise of the functions and powers and participation in governance at the local level; acknowledging that the functions of public entertainment and public amenities including liquor control, county recreation facilities and sports activities and facilities are vested in County Governments pursuant to paragraph 4 of Part Two of the Fourth schedule to the Constitution: concerned that high expectations, disappointing employment and life prospects, and marginalization among residents of Nairobi especially youth, fuels frustration and desperation and in response, some of these youths have turned to criminal behavior, violence, substance abuse, commercial sex work and even suicide, which have negative repercussions and contribute to growing physical insecurity in the society as a whole; **noting** that Section 5 of the Nairobi City County Alcoholic Drinks Control and Licensing Act 2014 provides for the functions of the Board which include establishment of treatment and rehabilitation facilities and programs for persons dependent on alcoholic drinks in each Ward; **further noting** that Part V of the Act establishes a fund which is to be used to promote cessation and rehabilitation programs in the County, this Assembly urges the County Executive to establish a treatment and rehabilitation centre in each Sub-County to serve as an information hub and treatment referral service for alcoholics and develop programs that are geared toward treating and rehabilitating alcoholics in the County.

NEW SCHEDULE Provision for the conduct of business affairs of the Committee

Meetings

- 1. (1) The Committee may meet at such place in Kenya as the chairperson may determine and the meetings will be convened by the Chairperson.
 - (1) The Committee shall have at least four meetings in every financial year and not more than three months than three months shall lapse between one meeting and the nest meeting
 - (2) Unless three quarters of the members otherwise agree, at least seven days' notice in writing of a meeting shall be given to every member by the Secretary of the Committee
 - (3) The Chairperson may at his discretion or at the written request made by at least half of the members of the Committee and within seven days of the request convene an extraordinary meeting at such time and place as he may appoint.
 - (4) The chairperson shall preside over all Meetings however, in his or her absence, the vice-chairperson shall preside over the meetings.
 - (5) The members of the Committee shall elect a vice-chairperson from among themselves-
 - (6) at the first sitting of the Committee and,
 - (7) whenever it is necessary to fill the vacancy in the office of the vice-chairperson
 - (8) Where the chairperson or vice chairperson is absent, the members shall appoint from among themselves, a person to chair the meeting of the Committee.

(9) The Committee may invite any person to attend any of its meetings and to participate in the deliberations, but such person shall not have a vote in any decision of the Committee.

Conflict of 2 in deliberations interest

2. (1) If any person has a personal or fiduciary interest

- regarding any deliberations and is present at a meeting of the Committee, at which any matter is the subject of consideration, that person shall at soon as practicable after the commencement of the meeting declare such interest and shall not take part in any consideration or discussion of or vote on any question touching such matter.
- (2) A disclosure of interest under (1) above shall be recorded in the minutes of the meeting at which it is made.

Quorum

- 3. (1) Subject to sub-paragraph (2) above, the quorum of the meeting shall not be less than half of the appointed members of the Committee.
- (2) where the persons present at a meeting of the Committee do not constitute the quorum necessary to hold a meeting under this act, or where by reason of the exclusion of a member from the meeting, the number of members fall below the quorum necessary to hold a meeting, the committee shall postpone the consideration of the matter in question until there is a quorum.

Voting

4. A question before the Committee shall be decided by simple majority of the members present and voting and the chairperson shall, in the case of any equality of votes, have a casting vote.

THAT, aware that Article 43 (1) (d) of the Constitution of Kenya, 2010 states that every person has a right to clean and safe water in adequate quantities; further aware that paragraph 11 (b) of the Part Two of the Fourth Schedule to the Constitution stipulates that the County Government is to provide County public works and services including water and sanitation services; concerned that most parts of the County especially informal settlements lack clean, safe, sufficient and affordable water, which has led to introduction of untreated water supply businesses within the County; acknowledging that the Nairobi City Water and Sewerage Company has continuously rehabilitated various sources of its water to ensure clean and adequate water supply; noting that the increasing population in the County implies increasing demand for basic amenities such as water supply, this Assembly urges the County Executive in conjunction with the Nairobi Metropolitan Services to establish strategic water points across the County to enable residents to have access to adequate, clean and safe water.
