The Temporary Speaker (Hon. Malyun Abdi, MCA) having confirmed that there was a Quorum at the commencement of the Assembly called the Assembly to order.

3. COMMUNICATION FROM THE CHAIR

The Speaker conveyed the following Communications:-

CONVENING OF THE SPECIAL SITTING

Hon. Members, May I take this opportunity to welcome you all to today's special sitting which has been convened at a time when the Assembly is on the long recess. I sincerely thank you for honoring the invitation despite the short notice. However, I recognize that leadership is best demonstrated and assessed during times when it is most inconveniencing and I have no doubt that by honoring this invitation, you have demonstrated the highest measure of commitment to the interests of the entire County.

Hon. Members, Pursuant to Standing Order No. 32, I received a letter dated 16th May, 2023 from the Leader of the Majority Party requesting that I convene special sittings today 18th May, 2023 commencing at 9.30 a.m for the morning Sitting and 2.30 pm for the afternoon Sitting. Accordingly, having reviewed the business proposed in the request and determined its urgency, I acceded to the said request and convened the Sittings. Consequently, today's special sitting was published in the Kenya Gazette dated 17th May, 2021 under the Gazette Notice No. 115 to consider the following business:-
