## 5. REQUEST FOR STATEMENTS.

The following statements were requested pursuant to Standing Order 47(2)(c): -

# 6. MOTION - CONSTRUCTION OF MARKET AND A PERIMETER WALL IN TOI MARKET, KIBERA WARD

Motion made and Question Proposed;

**THAT**, aware that Paragraph 2 of Part Two of the Fourth Schedule to the Constitution of Kenya 2010 provides for the functions of the County Government that include trade development and regulation of markets; **FURTHER AWARE** that Toi Market is one of the largest openair markets in Nairobi with over 5000 traders on the outskirts of Kibera slums in Nairobi. **DEEPLY CONCERNED** that the rise of arson attacks on informal markets in the County including Toi Market often suspected to be through human malicious act has led to significant economic losses, social unrest, and endangering the lives of traders and residents in Toi Market; CONCERNED THAT for the livelihoods of traders who have suffered significant losses due to repeated arson attacks and emphasizing the necessity of creating a safe and sustainable trading environment for their economic well-being. NOW **THEREFORE** this Assembly urges the County Executive to allocate sufficient funds from the County budget in the coming FY 2023/2024 alternative funding sources, including public-private partnerships, grants, or development loans, to finance the construction of the market, ensuring its timely completion and sustainability to undertake the construction of a well-planned, purpose-built market in the affected area, with the following objectives:

- i. Enhancing safety and security measures to prevent arson attacks, such as installing advanced fire suppression systems, robust security cameras, and employing adequate security personnel.
- ii. Providing proper infrastructure and facilities, including sheltered stalls, storage areas, sanitation facilities, and utilities, to ensure a conducive trading environment.
- iii. Collaborating with administrative authorities, community leaders, and stakeholders to ensure the design and construction of the market are inclusive, meeting the specific needs of the traders and the community.
