**8. POINT OF ORDERS – REQUEST FOR EXTENSION IN CONSIDERATION OF THE NAIROBI CITY COUNTY CIVIC EDUCATION BILL, 2023 (ASSEMBLY BILL NO. 9 OF 2023)**

Hon. Clarence Munga, MCA (Chairperson Sectoral Committee on Culture and Community Services) sort extension for consideration of the above mentioned Bill as follows;

**“Mr. Speaker,** The Nairobi City County Civic Education Bill, 2023 (Assembly Bill No. 9 of 2023), sponsored by Hon. Silas Matara, MCA, Member for Dandora Area 11 Ward, was read for the First time on **Tuesday, 5<sup>th</sup> December, 2023**. Subsequently, the Bill was committed to the Sectoral Committee on Culture & Community Services for scrutiny, public participation, and reporting to the Assembly.

**Mr. Speaker,** Upon committal, the Committee placed a notice in the local newspaper, particularly the Star Newspaper, on **16<sup>th</sup> February, 2024**, calling for a public participation forum, held on **Tuesday, 27<sup>th</sup> February, 2024**, to receive representations and proposals for amendments from the public as required by the Constitution and Nairobi City County Standing Orders.

**Mr. Speaker,** The Committee during its day-to-day engagement with its key stakeholders discovered significant emerging issues that needed to be factored in the Report of the said Bill. Moreover, the Committee noted that there was a need to align the existing Nairobi City County Public Participation Act, 2017 and The Nairobi City County Civic Education Bill, 2023. Further, the Committee observed that such issues are so crucial that they are cornerstones in the implementation if the Bill would be enacted into a law.

**Mr. Speaker,** In this regard therefore, the Committee seeks your indulgence in seeking for **extension** on Consideration of the Nairobi City County Civic Education Bill, 2023, which was read for the First time on **Tuesday, 5<sup>th</sup> December, 2023**. This would provide an opportunity for the Committee include key recommendations in the report that would enable smooth operationalization once the Bill is enacted into law.

**Mr. Speaker,** The Committee gives you assurance that the **final** report of the Sectoral Committee on Culture and Community Services on the Consideration of the Nairobi City County Civic Education Bill, 2023 **will be laid on the Table of the Assembly, First week after long recess** having captured in the said Report all necessary recommendations for easier implementation. In this regard, **Mr. Speaker,** on behalf of the Committee, I kindly request that you **grant** the **extension** on the Consideration of the Nairobi City County Civic Education Bill, 2023. Motion Made and Question Proposed

**THAT**, aware that Nairobi City County being the Capital City is the major entry point to the country and a major regional hub for business and tourism and that it presents the first image to guests visiting the country; **APPRECIATING THAT** globally, conduct of business recognized avenue for improvement of quality of life and a major contributor to revenue governments so long as such business is compliant to the governing laws of the country and County; **ACKNOWLEDGING THAT** Nairobi City County is a home to very industrious citizens a majority of who earn a living through provision of services and sale of goods to others and that in doing so, the County benefits through collection of fees and levies that are used in provision of services and development in priority areas; **CONCERNED THAT** the continued permission and licensing of business owners operating on temporary basis, such as shoeshines, confectionary, eggs and smoky vendors, to operate at unauthorized areas such as pavements, walk ways and roundabouts cause inconvenience to movement of pedestrians and encourages disorder in the Central Business District; **NOW THEREFORE**, this Assembly resolves that the County Executive designates vending zones in the backstreets pursuant to the Nairobi City County Pop up Markets and Street Vendors Act, 2021 for operation of the said temporary businesses and gives a vacation order requiring them to operate only in the designated spaces within the Central Business District.
