9. *MOTION – HON. WAITHERA CHEGE, MCA – DEPUTY MINORITY LEADER

Subject: Renaming of a County road after Senior Counsel Pheroze Nowrojee

Motion Made and Question Proposed;

AWARE that Article 186 (1) of the Constitution of Kenya 2010, and Paragraph 5 of Part 2 of the Fourth Schedule to the Constitution provide for transport including County roads, street lighting, public road transport traffic, and parking as a devolved county function; **FURTHER AWARE** that the Country has since independence named and renamed roads and other public facilities in honor of heroes and heroines who have contributed immensely in the society as a way of honoring them; **APPRECIATING** the late Pheroze Nowrojee SC , who was a distinguished and patriotic Kenyan lawyer, human rights defender, a poet, historian and patriot; who made indelible contributions to the Nation through his dedicated service and deep commitment to justice, human dignity, and the rule of law; his early legal training in Kenya, and later years in India, United Kingdom and the United States of America gave him a unique blend of local understanding and global perspective, that informed his work throughout his life. He was a kind of advocate who pursued justice over grandstanding and or profit, often offering his services pro-bono whenever the occasion so required, and who believed in the sanctity of the Constitution, even in the most turbulent political climates; In acknowledging some of the immense contributions by Senior Counsel Pheroze Nowrojee, in 1995, the Kenyan section of the International Commission of Jurists (ICJ Kenya) awarded him the Jurist of the Year, a recognition reserved for individuals who have demonstrated

exceptional commitment to the protection and promotion of human rights, justice, and the rule of law; SC Pheroze Nowrojee, was also recognized by the International Bar Association in 1995, he received the Bernard Simons Human Rights prize for 2002- 2004, the Law Society Roll of Honor 2005, The Maasai People Safeguarding Rights Award 2007, the CB Madan Constitutional prize 2014; He was a distinguished lecturer in the University of Dar salaam, University of Nairobi and Kenya school of law; he was a distinguished scholar and author of many books among them A vote for Kenya, The elections and the constitution 2013 and A Kenyan Journey 2014, among others; **RECOGNIZING** that County established a County Policy on property addressing and street naming which provides for procedures that should be undertaken in relation to address management functions, such as address selection and naming of roads and streets within the County; **FURTHER APPRECIATING** that by renaming of a prominent road in Nairobi would serve as a fitting tribute to his lasting legacy and ensure that his contributions are remembered and celebrated by future generations, this **ASSEMBLY THEREFORE URGES** the County Executive to rename a County road after the late Senior Counsel Pheroze Nowrojee in recognition of not only his patriotism, excellent contribution to the rule of law human rights and democracy and generally good governance in the Republic of Kenya but also the values he espoused: justice, integrity, humility, and above all, service to humanity

11. MOTION – HON.PERPETUA MPONJIWA, MCA

Subject: Development and Implementation of a Comprehensive Local Tourism Policy for Nairobi City County

AWARE THAT, Article 174 of the Constitution of Kenya, 2010 outlines the objects of devolution, including the promotion of social and economic development

and to foster national unity by recognizing diversity; Article 185 (4)(a) further mandates the County Assembly to receive and approve plans and policies for the management and exploitation of the county's resources; **FURTHER AWARE THAT**, Article 186 and the Fourth Schedule of the Constitution assign functions related to cultural activities, public entertainment, amenities, and local tourism to county governments; **RECOGNIZING THAT**, Nairobi City County, as the capital city and economic hub of Kenya and the East and Central African region, holds a unique potential for cultural, historical, conference, medical, urban, and eco-tourism; **NOTING THAT**, the Kenya Vision 2030 recognizes tourism as a key economic pillar and emphasizes the development and diversification of tourism products, including promotion of cultural and urban tourism; **CONCERNED THAT**, despite its strategic importance, cosmopolitan character, and rich historical, social, and cultural heritage, Nairobi City County has not yet developed or implemented a comprehensive local tourism policy to harness its full tourism potential and distinguish itself as a premier tourism destination; **DEEPLY CONCERNED THAT**, the lack of an integrated framework and

coordinated strategy has led to under-utilization of Nairobi's potential for local tourism, employment creation, youth engagement, and socio-economic

empowerment; **NOW THEREFORE**, this Assembly **URGES** the County Executive Committee Member responsible for Tourism and Culture:

1. To initiate and fast-track the development of a Comprehensive Nairobi City County Local Tourism Policy in line with the Constitution of Kenya, the County Governments Act, 2012, the Tourism Act, 2011, the Nairobi Integrated Urban Development Master Plan (NIUPLAN) – which has identified tourism and heritage as part of Nairobi’s economic revitalization agenda, alongside other relevant policy frameworks;
2. To ensure that the policy provides for:
 - a) Mapping, preservation, and promotion of local heritage, cultural assets, and public amenities;
 - b) Strategic development and marketing of unique tourism products tailored to the Nairobi context;
 - c) Inclusive participation of local communities, youth, women, and creative sectors in tourism development;
 - d) Public-private partnerships (PPPs) and stakeholder collaboration in resource mobilization and service delivery;
 - e) Integration with national tourism promotion initiatives under the Kenya Tourism Board, Magical Kenya and other entities;
3. To submit the draft policy to this Assembly within six months for consideration and adoption.
