— **CAPACITY ASSESSMENT AND RATIONALIZATION OF THE PUBLIC SERVICE: BIOMETRIC DATA CAPTURE FOR MEMBERS OF THE COUNTY ASSEMBLY**

“Honourable Members,

As you are aware, the National Government recently launched the capacity assessment and rationalization of the public service through biometric data capture and verification in all counties in order to capture details of State Officers and Public Servants in their respective work stations.

All public servants and State Officers are required to present themselves at identification centres to ensure their data is captured through the biometric registration exercise. Failure to participate in this exercise would occasion the loss of earnings for persons whose details will not have been captured.

Hon. Members, you are therefore requested to kindly present yourself for the said headcount on **Thursday 30th October, 2014** at the former Mara Restaurant, next to the Assembly's Charter Hall. The exercise will commence at **8.00am** and terminate at **5.00pm**.

Please bring with you your original:-

- (i) National Identity Card;
- (ii) Pay slips for the months of September and October;
- (iii) Birth Certificate;
- (iv) Original Education Certificates;
- (v) Dully filled biometric data capture form.
