1. The Assembly assembled at twenty four minutes to Three O'clock.
2. The Proceedings were opened with Prayer.

QUORUM OF THE ASSEMBLY

The Chairperson of Committees (Hon. Kennedy Ng'ondi) having confirmed that there was no Quorum caused the Bell to be rung for Ten minutes.
