4. NOTICE OF MOTION – (Hon. Elizabeth Manyala, MCA)

THAT, aware that Article 26 (1) of the Constitution of Kenya 2010 provides that every person has the right to life; Further the article 53 (2) of the constitution states that best interests of the child which is now to be paramount in every matter concerning children; concerned that there is increased rate of road carnage involving school going children in Nairobi City County especially in public schools; acknowledging the measures the National Transport and Safety Authority (NTSA) has put in place to ensure road safety performance in line with international best practice, this Assembly urges the County Executive to erect or put bumps and signals along County roads that are near schools and other social amenities to save vulnerable schools children from accidents on roads.
