THAT, aware that Article 43 (1) (a) of the Constitution of Kenya (2010) states that every person has the right to highest attainable standards of health including the right to health care services; further aware that pursuant to paragraph 2 of Part 2 of the Fourth Schedule to the Constitution, the County Government is mandated to promote primary health care including county health facilities; concerned that the ongoing strike by nurses across the County has paralyzed delivery of services in the county health facilities, thus denying residents of the County the right to access health care; acknowledging that the issue of nurses have been on strike in different occasions due to various factors such as lack of salary even up to six months, this Assembly adjourns pursuant to Standing Order 30 to discuss the challenge of health care services including the ongoing nurses' strike as a matter of definite urgent County importance.
