1. MOTION – HON. PETER IMWATOK, MCA – MAJORITY LEADER

Subject: *Construction of market and a perimeter wall in Toi Market, Kibera Ward*

THAT, aware that Paragraph 2 of Part Two of the Fourth Schedule to the Constitution of Kenya 2010 provides for the functions of the County Government which include trade development and regulation of markets; **FURTHER AWARE** that Toi Market is one of the largest open-air markets in Nairobi with over 5000 traders on the outskirts of Kibera slums in Nairobi. **DEEPLY CONCERNED** that the rise of arson attacks on informal markets in the County including Toi Market often suspected to be through human malicious act has led to significant economic losses, social unrest, and endangering the lives of traders and residents in Toi Market; **CONCERNED THAT** for the livelihoods of traders who have suffered significant losses due to repeated arson attacks and emphasizing the necessity of creating a safe and sustainable trading environment for their economic well-being. **NOW THEREFORE** this Assembly urges the County Executive to allocate sufficient funds from the County budget in the coming FY 2023/2024 or seek alternative funding sources, including public-private partnerships, grants, or development loans, to finance the construction of the market, ensuring its timely completion and sustainability to undertake the construction of a well-planned, purpose-built market in the affected area, with the following objectives:

- i. Enhancing safety and security measures to prevent arson attacks, such as installing advanced fire suppression systems, robust security cameras, and employing adequate security personnel.
- ii. Providing proper infrastructure and facilities, including sheltered stalls, storage areas, sanitation facilities, and utilities, to ensure a conducive trading environment.
- iii. Collaborating with administrative authorities, community leaders, and stakeholders to ensure the design and construction of the market are inclusive, meeting the specific needs of the traders and the community.

**MOTION – HON. DR. CLEMENT NG'ANG'A KAMARU, MCA.**

**Subject: Introduction of a community service for all the drink and drive convictions in the County Mortuary facilities for deterrence.**

**AWARE** that Article 183 (3) (c) of the Constitution of Kenya, 2010 provides that County Executive Committee shall *inter-alia* implement, within the county, national legislation to the extent that the legislation so requires; **NOTING** that Section 44 of the Traffic Act (Cap 403) provides that any person who, when driving or attempting to drive, or when in charge of a motor vehicle on a road or other public place, is under the influence of drink or a drug to such an extent as to be incapable of having proper control of the vehicle, shall be guilty of an offence and liable to a fine not exceeding one hundred thousand shillings or to imprisonment for a term not exceeding two years or to both; **FURTHER NOTING** that Section 4 (2) (d) of the National Transport and Safety Authority, 2012 dictates that the Authority while performing its functions under the Act, shall develop and implement road safety strategies; **DEEPLY CONCERNED** that despite the existing statutory provisions, regulations and mitigations on road safety towards deterrence of drunk driving, road carnage as a result of same remains on the rise in the County and Country at large, covering 32% of all the reported road accidents, with such cases recorded on late nights in the weekends; **ACKNOWLEDGING** the need for a multi-agency approach towards deterrence of drunk driving by introduction of community service for the offenders as a way of changing of attitude and bring awareness of the eminent risk of loss of life associated with such unlawful and unethical act; **FURTHER ACKNOWLEDGING** the need for collaborative approach by the National Government, the Judiciary and the County Government as provided for in Article 189 of the Constitution of Kenya, 2010 in mitigating the drunk driving behavior in the County; this **ASSEMBLY URGES** that the County Executive moves with speed and:-

1. Partner with the National Transport and Safety Authority and the Judiciary through the City Courts towards introduction of a mandatory post-conviction Community service for all the Drink and Drive case in the County;
2. Provide for Community service to be conducted in the existing Nairobi City County Mortuary facilities focusing on administrative and compound cleaning duties under the supervision and clearance by the facility's chief administrator;
3. Undertake a sensitization talk from the facility's chief administrator on the risk associated with drink and drive and information on death cases as result of drunk driving; and,
4. Develop a policy that would see the introduction of the Community Services for the convicted drunk and drive cases in the County.

**MOTION – HON. SOSPETER MUMBI, MCA**

**Subject: Installation of Speed limit signs and Increase Pedestrian Cross on the County Roads**



**THAT**, aware that under Article 186 (1) of the Constitution of Kenya, and paragraph 5 of the Second Part of the Fourth Schedule to the Constitution, the functions and powers of County Government, among others, include County transport which includes county roads, street lighting, public road transport traffic and parking; **further aware that** the City has designated preferential zebra crossing throughout the City County roads; **noting that** recent years have witnessed a marked increase in the number of vehicles plying various routes in the County as well as increased pedestrian population; **concerned that** most county roads have limited marked speed limits and zebra crossing which has led to increased traffic congestion and accidents including deaths to pedestrians caused by speeding motorists; **further noting that** the few available legal speed limits and zebra crossing points were done long time ago when the City had few vehicles and pedestrians population, this Assembly urges the County Executive to:-

1. undertake an audit of County Roads with a view to redesignate more speed limit areas and increase designated pedestrian cross where necessary and rehabilitate the existing ones with visible signs to ease traffic flow and minimize road carnage across all County Roads; and
2. enforce the speed limits and other traffic rules with the aid of modern technology.
