1. \*MOTION – CHAIRPERSON, SELECT COMMITTEE ON PROCEDURE & RULES

Subject: *Adoption of report*

**THAT**, this Assembly adopts the **REPORT OF THE SELECT COMMITTEE ON PROCEDURE AND RULES ON AMENDMENT OF THE STANDING ORDERS**, laid on the Table of the Assembly on Wednesday, 18<sup>th</sup> October, 2023.

2. \*MOTION – HON. PETER JATESO IMWATOK, MCA – MAJORITY LEADER

Subject: *Operationalization of the Sports Fund*

**THAT**, aware that Paragraph 4 (h) of Part 2 of the Fourth Schedule to the Constitution of Kenya (2010) mandates County Governments with the responsibility of managing sports activities and facilities; **FURTHER AWARE** that, the Nairobi City County Assembly enacted the Nairobi City County Sports Management Act, 2017 to provide for the management, promotion and regulation of sports in the County; **NOTING** that, Section 11 of the said Act provides for the establishment of the Sports Fund whose purpose amongst others is to fund the training, research, development and capacity building of sports activities in accordance with the Sports Plan contemplated under Section 8 of the said Act; **CONCERNED** that, despite these clear provisions of the law, the County Executive is yet to establish the Sports Fund to support sporting activities in the County as envisioned in the Act thus hampering the development of sports; **FURTHER CONCERNED** that, sporting teams that represent the County in various national competitions have been turned into beggars depending on well-wishers which is not only heartbreaking but humiliating as well; this Assembly **RESOLVES** that the County Executive:-

- i) Operationalize the Sports Fund as envisioned under Sections 10 and 11 of the Nairobi City County Sports Management Act, 2017 and further that the funds be utilized in supporting sporting teams in the County;
- ii) Factors monies in the Budget Estimates for the FY 2024/25 for purposes of the Fund; and
- iii) Develops and submit to the County Assembly Regulations contemplated under Section 16 of the said Act within three (3) months of adoption of this Motion. The regulations should amongst other things provide for the management of the Sports fund.

3. \*MOTION – HON. PETER JATESO IMWATOK, MCA – MAJORITY LEADER

Subject: *Establishment of an Ad-Hoc Committee to Investigate the County Local Revenue Collection System(S) And Administration*

**A. MOTION – HON. AMI AMBALA, MCA**

**Subject: To conduct a mandatory mental health assessment of all its employees in the County with an aim of sensitizing, diagnosing and recommending treatment.**

**AWARE THAT** paragraph 2 of Part 2 of the Fourth Schedule to the Constitution of Kenya, 2010, provides for primary health as one of the devolved County Government's function; **CONCERNED THAT**; according to the Kenyan National Commission of Human Rights an estimate of 25% and 40% of outpatients and inpatients suffer from mental health conditions, with most frequent diagnoses of mental illnesses made in general hospital settings being depression, substance abuse, stress, and anxiety disorders; **FURTHER CONCERNED THAT**; public serve has not been an exception as evident by the rising cases of mental health with alarming rate of alcohol and substance use, anxiety disorders ,suicides , occupational injuries, workplace conflicts and absenteeism leading to a decline in quality of service delivered and productivity among public officers; **ACKNOWLEDGING THAT**; there is need of urgent prevention and mitigation measures by public and private sector employers that will enable timely sanitization, counselling and assessment of mental health cases without stigmatization; this **ASSEMBLY THEREFORE RESOLVES** that the County Executive conducts a mandatory mental health assessment of all its employees in the County with an aim of sensitizing, diagnosing and recommending treatment for any mental health cases for the same and the exercise to be emulated by the private sector.

**Subject: Regulations for Accountability by Non-Governmental Organizations operating within the County**

**THAT**, aware that Part Two of the Fourth Schedule to the Constitution of Kenya 2010 provides for the functions of the County Governments which include Ensuring and Coordinating the participation of communities and locations in governance at the local level and assisting communities and locations to develop the administrative capacity for the effective exercise of the functions, powers and participation in governance at the local level; **further aware that** Nairobi City County is host to various Regional, National and International Non-Governmental Organizations that champions the key values of Probity, Transparency, Accountability, Justice and Good Governance, Climate change, Health, Gender and development, Children's rights, poverty alleviation, Peace, Population, Training, Counselling small scale enterprises, Disability and any other issues that affect society at large; **acknowledging that** pursuant to Sections 3 and 7 of the Non-Governmental Organizations Co-ordination Act, 1990 which established the Non-Governmental Organizations Co-ordination Board with the responsibility of regulating and enabling the Non-Governmental Organization sector in Kenya; **noting that** Non-Governmental Organizations operating within the County play a complementary role in providing services and essential facilities, thereby contributing to the County's development through the realization of the social and economic pillars of Vision 2030; **further noting** that the established Non-Governmental Organization Council that provide self-regulation of NGOs and assist them to realize their potential in improving services that advance the socio-economic status of Kenyan society in pursuit of sustainable development, this Assembly urges the County Executive in conjunction with the Non-Governmental Organizations Co-ordination Board to develop guidelines that provides for Non-



Governmental Organizations to publish and publicize programmes and projects undertaken in the Wards within the County for accountability.
