# 1. MOTION – HON. PETER JATESO IMWATOK, MCA – MAJORITY LEADER Subject: Status of County Government Staff Establishment

**THAT**, aware that, Article 176 of the Constitution of Kenya (2010) establishes County Governments comprising of the County Assembly and the County Executive. FURTHER AWARE that, Article 235 of the CoK (2010) provides for the County Government to establish a County Public Service and appoint persons to serve in the said Service; **APPRECIATING** that the service referred to herein include the service within the County Executive, County Assembly and County Corporations established pursuant to the provisions of the Nairobi City County Corporations Act, 2019 and any other written law; NOTING that, Nairobi City County Government has been grappling with a huge wage bill occasioned by overstaffing in certain cadres within its staff establishment; RECOGNISING that, the Controller of Budget, the Auditor General and this Assembly have on numerous occasions recommended for the reduction of the wage bill in order for the County Government and its entities to comply with the provisions of Section 15 (2) (a) of the Public Finance Management Act, 2012 and to be able to meet its development goals; CONCERNED that, despite these recommendations, the County Government and its entities has continued to recruit and/or extend the term of service of officers in the service beyond the mandatory retirement age of sixty (60) years contrary to the provisions of Section 80 (1) (a) and (b) of the Public Service Commission Act, 2012 and Circulars Ref. No. PSC/ADM/13 (7) dated 19th November, 2020 by the Public Service Commission and Ref. No. MPSG& AA.1/5/1/1 dated 16th February, 2023 by the Ministry of Public Service; NOW THEREFORE, this Assembly RESOLVES: -

- (i) That all staff in the County Executive, County Assembly and Nairobi City Water and Sewerage Company (NCW&SC) service who have attained the mandatory retirement age proceeds to retire with immediate effect;
- (ii) That all staff who are due for mandatory retirement within the County Executive, County Assembly and Nairobi City Water and Sewerage Company (NCW&SC) service proceeds for terminal leave as prescribed under the Public Service Commission Human Resource Manual and applicable legislations with immediate effect; and
- (iii) That the County Secretary and the NW&SC Board provides a written response to the County Assembly within seven (7) days of adoption of this Motion on the implementation of the resolutions herein.

# 1. MOTION - HON. MARK MUGAMBI, MCA - MINORITY WHIP

#### Subject: Support for football teams in the County

**THAT**, aware that paragraph 4 of part 2 of the Fourth Schedule of the Constitution of Kenya, 2010 provides for Cultural activities, public entertainment and public amenities, including; sports and cultural activities and facilities as a county function; FURTHER AWARE, that section 10 & 11 of the Nairobi City County Sports Management Act, 2017 provides for guidelines on financial support for sports initiatives and facilities in Nairobi County; **DISTURBED** that many grassroots football teams in Nairobi County struggle to meet the financial obligations required for registration in the Football Kenya Federation (FKF) league; RECOGNIZING THAT football plays important role in society of promoting unity, health and talent development in our communities including creation of employment for youth; ACKNOWLEDGING that the facilitation of annual registration fees by the Nairobi County Executive would significantly boost the development of local football, empower youth and promote sports as a tool for development; Strengthen partnership between Nairobi County and sports organizations & enhance reputation of Nairobi as a hub for sports excellence; DEEPLY CONCERNED THAT local teams face challenges in affording the annual registration fees required by the Football Kenya Federation (FKF) in order to effectively participate in tournaments. This Assembly therefore urges that the County Executive to; -

- i) Allocate funds in the County's sports budget to cover the annual FKF fees for registered football teams in Nairobi County;
- ii) Develop criteria for allocation of funds to the teams which shall be informed by parameters such as the team's active participation in local tournaments, adherence to FKF regulations and engagement in youth development; and
- iii) Form a committee that will administer and monitor the use of funds and ensure transparency and equity.

#### 3. MOTION – HON. JOHN REX OMOLLEH, MCA

Subject: Operationalization of the Nairobi City County Outdoor Advertising and Signage Control and Regulation Act of 2018 and Development of Regulations to ban adverts on electricity poles, public walls across the County

THAT, aware that Part Two of the Fourth Schedule of the Constitution of Kenya 2010 provides for the functions of the County Governments which include control of air pollution, noise pollution, other public nuisances and outdoor advertising; further aware that the County Assembly passed the Nairobi City County Outdoor Advertising and Signage Control and Regulation Act, 2018 which provides for the regulation of outdoor advertisement and signage within the County; concerned that there are several adverts and posters erected in various public places such as electricity poles, streetlight poles, public walls and buildings, which has not only affected the aesthetics of the City but have not complied with the Nairobi City County Outdoor Advertising and Signage Control and Regulation Act, 2018; further concerned that the County Assembly passed the Nairobi City County Outdoor Advertising and Signage Control and Regulation Act, 2018 which has not been published, publicized and operationalized to date; noting that Section 7 (I) of the Nairobi City County Office of the County Attorney Act, 2017 provides that the County Attorney shall publish all legislation passed by the County Assembly, this Assembly resolves that:

- 1. The County Attorney to publish the Nairobi City County Outdoor Advertising and Signage Control and Regulation Act, 2018 within fourteen (14) days after the adoption of this Motion; and
- 2. County Executive Committee Member responsible for Urban Planning to develop Regulations pursuant to the provisions of Section 27 of the said Act to provide for a ban on illegal adverts and posters erected in various public places such as electricity poles, streetlight poles, public walls and buildings across the County.
