1. * PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on Bills Sponsored by Parties or Committees*

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on **Bills** sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five (45) minutes for the Mover, in moving and fifteen minutes (15) in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

2. * PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on Motions*

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on any **Motion**, including a Special motion be limited in the following manner:-A maximum of three hours with not more than twenty (20) minutes for the Mover and ten (10) minutes for each other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each, and that ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.



3. *PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on Individual Members' Bills*

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on **Bills NOT** sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty (30) minutes for the Mover, in moving and ten (10) minutes in replying, a maximum of thirty (30) minutes for the Chairperson of the relevant Committee and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes (15) each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Sectoral Committee, in that Order.

4. *PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on Reports*

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, each speech in a debate on a **Report of a Committee**, a Sessional Paper or any other Report submitted to the Assembly, be limited as follows: - A maximum of sixty (60) minutes for the Mover in moving and thirty (30) minutes in replying, and a maximum of ten (10) minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen (15) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that Order.

5. *PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on the Motion on the Address by the Governor*

THAT, pursuant to the provisions of Standing Order 106(1), and in furtherance to the provisions of Standing Order 27(5), this Assembly **orders** that debate on the **Motion on the Address by the Governor** be limited to no more than five (5) minutes for each Member Speaking, thirty (30) minutes for the Mover in moving and replying and twenty (20) minutes for the Leader of Minority Party.

6. *PROCEDURE MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Limitation of Debate on the Adjournment Motion*

THAT, pursuant to the provisions of Standing Order 106(1), this Assembly **orders** that, the debate on any **Motion for the Adjournment** of the Assembly to a day other than the next normal Sitting Day in accordance with the Calendar of the Assembly, be limited to a maximum of three (3) hours with not more than five (5) minutes for each Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of ten (10) minutes each; and that priority be accorded to the Leader of the Majority Party and the Leader of the Minority Party, in that order. Provided that, when the period of Recess proposed by any such motion does not exceed ten (10) days, the debate shall be limited to a maximum of thirty minutes (30), and shall be strictly confined to the question of the adjournment.

7. *MOTION – THE LEADER OF MAJORITY PARTY

Subject: *Approval of the County Assembly Calendar for the Fifth Session*

THAT, pursuant to the provision of Standing Order 31(1), this Assembly approves the Calendar of the County Assembly (Regular Sessions) for the Fifth Session (2026) as contained in the Schedule.
